

# Request for Rectification, Erasure, and Restriction of Processing of Personal Data in the Border and Territorial Control Register and/or Entry/Exit System (EES)

You can request rectification, erasure, and restriction of the processing of personal data in the Border and Territorial Control Register and/or Entry/Exit System (EES).

The right to rectification, erasure, and restriction of processing is provided by the General Data Protection Regulation (GDPR) Articles 16 to 18. For the Entry/Exit System, this is also governed by EES Regulation Article 52.

You can use this form if you wish to request rectification, erasure, or restriction of processing of personal data in the Border and Territorial Control Register and/or Entry/Exit System (EES). Once you have completed the form, you can send it to Øst Police District (Postboks 3390, 1402 Ski).

The police emphasize that you should not send the form via email, as email is often sent unencrypted. Confidential, sensitive, or other classified information should not be sent via email, including messages containing a national identification number.

The response to the request will be sent to your registered address. If you do not have a registered address in Norway, the response will be sent to the address you provide in this form.

Parents/guardians can independently request rectification, erasure, or restriction of processing for a child under the age of 15. The request must be signed by a parent/guardian. From the age of 15, the individual to whom the data pertains can request rectification, erasure, or restriction of processing under the GDPR. Parents may exercise these rights on behalf of children over 15 when the child consents to this or when necessary for parental responsibility.

### **Border and Territorial Control Register**

The Border and Territorial Control Register is a national register of travelers that manages the police's administrative tasks related to entry and exit control, as well as immigration control within the territory. The processing of data in the register also has a crime prevention purpose. Detailed provisions on the register are given in the Border Regulations, Chapter 5.

The police register information on persons and travel documents/ID documents, as well as the time and place of border crossings/immigration controls.

## Entry/Exit System (EES)

The Entry/Exit System (EES) is a European information system that registers data on entry and exit, as well as refused entry, for third-country nationals on short-term stays who cross the external borders of the Schengen area. It registers information on the person, travel documents, and visa, in addition to fingerprints and facial photos. Detailed provisions on the system are given in the EES Regulation (EU 2017/2226).

### **Identification**

### What do we accept as valid identification?

- Valid passport (not emergency passport)
- Norwegian bank card with photo
- Norwegian driver's license original and duplicate (not older driver's license "green driver's license")
- Nordic driver's licenses of EU/EEA standard
- Ministry of Defence ID card (from 2004)
- Valid postal ID card issued after October 1, 1994
- National ID card issued within the EEA
- Asylum seeker ID card, along with a signature and place of birth
- Norwegian refugee travel document (green passport)
- Norwegian passport for foreigners (blue passport)
